DEHP Authorisation: Industry calls for regulatory predictability

ECPI is pleased to learn that the REACH Committee has confirmed the Authorisation for the recycling of flexible PVC made with DEHP, based on the recommendations of the ECHA Committee for Risk Assessment (RAC) and the Committee for Socio-Economic Analysis (SEAC).

No causal link found in study linking phthalates to fast-food

ECPI would like to reassure consumers of the safety of all phthalates used in current applications in response to a report published in Environmental Health Perspectives. The study published showed very low exposure and moreover, the researchers tested individuals' dietary recall of foods ingested within a 24 hour period without previously measuring their actual levels of phthalates or confirming their presence in any of the ingested foods. >>Read more

Potential Restrictions: Legislative clarity and consistency needed

ECPI is concerned about ECHA's and the Danish EPA's proposal for broad restrictions on DEHP, BBP, DIBP and DBP in articles for which RAC has already concluded twice in the last four years (in 2012 and 2014) that there is no risk to the general population. The case of DEHP represents an important precedent for many chemicals which are undergoing the REACH Authorisation and Restriction processes. A scientific approach is essential to give a strong signal of legislative clarity and consistency. The public consultation is open until 15 December 2016. >>> Public Consultation
