REGULATORY UPDATES

ChemSec's decision to keep DINP on its SIN list contradicts ECHA's RAC conclusion
ChemSec has recently communicated its decision to maintain DINP on their SIN list, which does
not reflect the conclusions published earlier this year by ECHA's Risk Assessment Committee
(RAC). Based on a scientific assessment of all the available data, RAC concluded that "no
classification for DINP for either effects on sexual function and fertility, or for developmental
toxicity is warranted." >> Read more

ECHA opens consultation on amendment to four phthalates' Authorisation entries The European Chemicals Agency (ECHA) has launched a public consultation on the amendment to the Authorisation list entries of four phthalates. The amendment would add endocrine disruptive properties to DEHP, DBP, BBP, and DIBP. The deadline for comments is 12 March 2019. >> Read more

European Plasticisers comments on inaccuracies and inconsistencies of two studies published by Radke et al (2018) and by Bornehag et al (2018). Specifically, Radke et al did not consider ECHA's RAC opinion that no classification for DINP for either effects on sexual function and fertility or for developmental toxicity is warranted. Bornehag et al did not take into consideration other scientific studies that show that phthalate exposure levels of children living in Europe do not influence their language or communication skill developments.>> Read more
