REGULATORY UPDATES

European Plasticisers prepares submission for food contact materials consultation

The European Food Safety Agency has launched a public consultation on the draft update of its 2005 risk assessments of five phthalates. EFSA is proposing a group tolerable daily intake (TDI) of 50 µg/kg bw per day for DBP, BBP, DEHP and DINP. European Plasticisers considers such grouping inconsistent with the recent RAC conclusions that DINP does not have adverse reproductive effects warranting classification. European Plasticisers will provide these and other scientific comments. >> See announcement

Guidelines for assessing phthalates in medical devices being drafted

The European Commission's SCHEER Committee has published draft guidelines to compare the risks and benefits of phthalates under new EU regulations covering medical devices. The guidelines propose a methodology for this assessment, which could also eventually apply to other substances. The public consultation closes on April
